

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the www.sixthreats.com and Six Threats Book and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Six Threat's website include www.sixthreats.com. The Six Threats website is a book site. By using the Six Threats website, you consent to the data practices described in this statement.

Collection of your Personal Information

Six Threats may collect personally identifiable information, such as your name. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by Six Threats. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the S Six Threats website.

Sucuri Security

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

Children Under Thirteen
